CONTRACT TERMS FOR ORDERED EQUIPMENT

1. Order - Order form

Ordered services need to be stated in correctly filled in order form for arrangement of the exhibition space. Orderer has to submit the order to Organizer 21 days before the fair opening at the latest. For orders of technical connections and other equipment not received 21 days prior to the event at the latest, the price shall be increased by 50%. Exhibitor orders services and acknowledges organizer's conditions irrevocably by confirming the order. For Exhibitor, the order is a binding and an irrevocable contract. Reserved orders will not be considered by organizer.

2. With the order, orderer binds to pay the services clearly marked on the order form according to the valid price-list of technical services and organizer's terms.

3. A condition for realization of the order is a correctly filled in form and payment of the obligations by the proforma invoice issued by organizer.

4. Organizer hereby also reserves the right to choose the material and equipment to realize the order at his own discretion unless otherwise agreed.

5. Cancellation of Order by Exhibitor

In case of cancellation more than 7 days prior to the fair opening, organizer is entitled to a cancellation fee amounting to 39% of the order value. If cancellation is given less than 7 days prior to the fair opening, the cancellation fee amounts to 75% of the order value. In both cases the cancellation fee is agreed as lump sum damages reimbursement.

6. Prices and Payments

Orderer receives a proforma invoice and undertakes to pay the amount in full until order deadline. The settlement of the proforma invoice in due time is the condition for the realization of the order. After realized order orderer is issued an invoice by organizer. Organizer reserves the right to charge for apportioned interests due for overdue payments. Objections to the invoice should be taken within 8 days of the issue of the invoice. If orderer objects only to one part of the invoice, he is obliged to settle the undisputed part within the said deadline.

7. Cancellation of Order by Organizer

Organizer is entitled to withdraw from the confirmed order in the following cases:

- if orderer hasn't settled his obligations duly,
- if organizer claims outstanding debts from orderer due from other transactions,
- if orderer's claims do not comply with the technical rules of safety of the fair exhibitions.

8. In case the event does not take place for any reason, organizer is entitled to payment of at least 50% of the agreed order value.

9. Technical Conditions

Orderer must submit all technical requirements necessary for putting up the exhibition space, or the preparation of technical connections/attachments, as well as the special requirements for additional equipment and services in due time, stated in the form. When placing the relative orders it is necessary to comply with all current regulations relative to fire prevention, safety at work and rules of the house.

10. Acceptance (Taking Over) Conditions

The acceptance of the realized order shall be performed by orderer and organizer within the following time limits:

- for the exhibition site 12 hrs before the opening of the event,
- by the time of the opening of the event for additional orders ordered at least 24 hrs before that time. Orderer, who has not accepted the realized order shall not be entitled to raise a claim for the executed services, if the same has been realized in compliance with the order.

11. Liability and Insurance

- Orderer shall safeguard the leased equipment and material. Organizer shall allow no pasting, drilling and refixing without organizer's approval. Orderer shall have full substantial liability for any damages or loss occurred.
- Orderer shall also be liable for damages caused by unsuitable handling of leased equipment, material and connections.
- Organizer shall accept no liability for any incomplete or incorrect orders (forms). Organizer shall charge all corrections and additional interventions caused by incomplete orders.
- Organizer shall allow no modifications of constructions, installations or equipment without organizer's approval.
- Orderer shall not be allowed to assign the allocated exhibition space or any part of it, or the leased equipment, or connections to third parties. In case this provision would be violated, organizer reserves the right to charge additional 50% of the order value as contract fine.
- When leaving the exhibition space, the lights should be switched off on the fixed fit switch board. Organizer shall not allow hanging of the exhibits on the walls in contact with reflectors. The distance between the exhibits and the reflectors must be minimum 1 meter.

12. Orderer shall renounce all objections from its copyright title.

13. Organizer shall hand back a clean exhibition space and working equipment.

14. All eventual disputes between the contract parties shall be submitted to the Court in Ljubljana.
